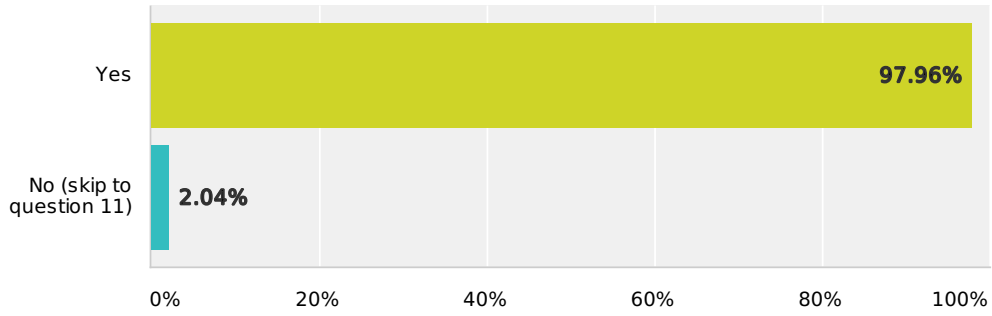


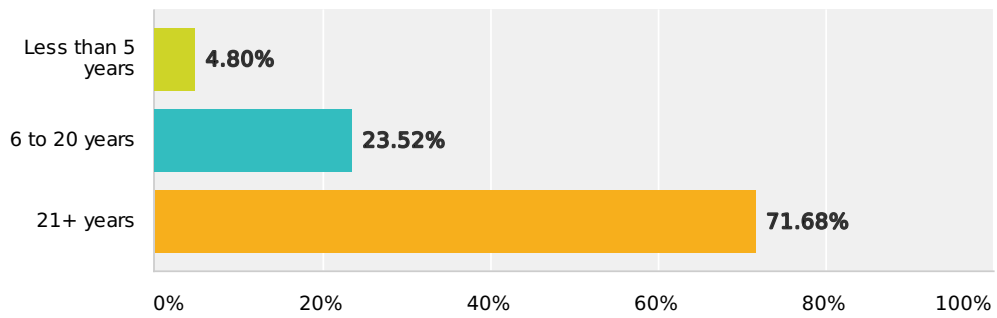
Q1 Have you hunted deer in Vermont in the past 5 years?

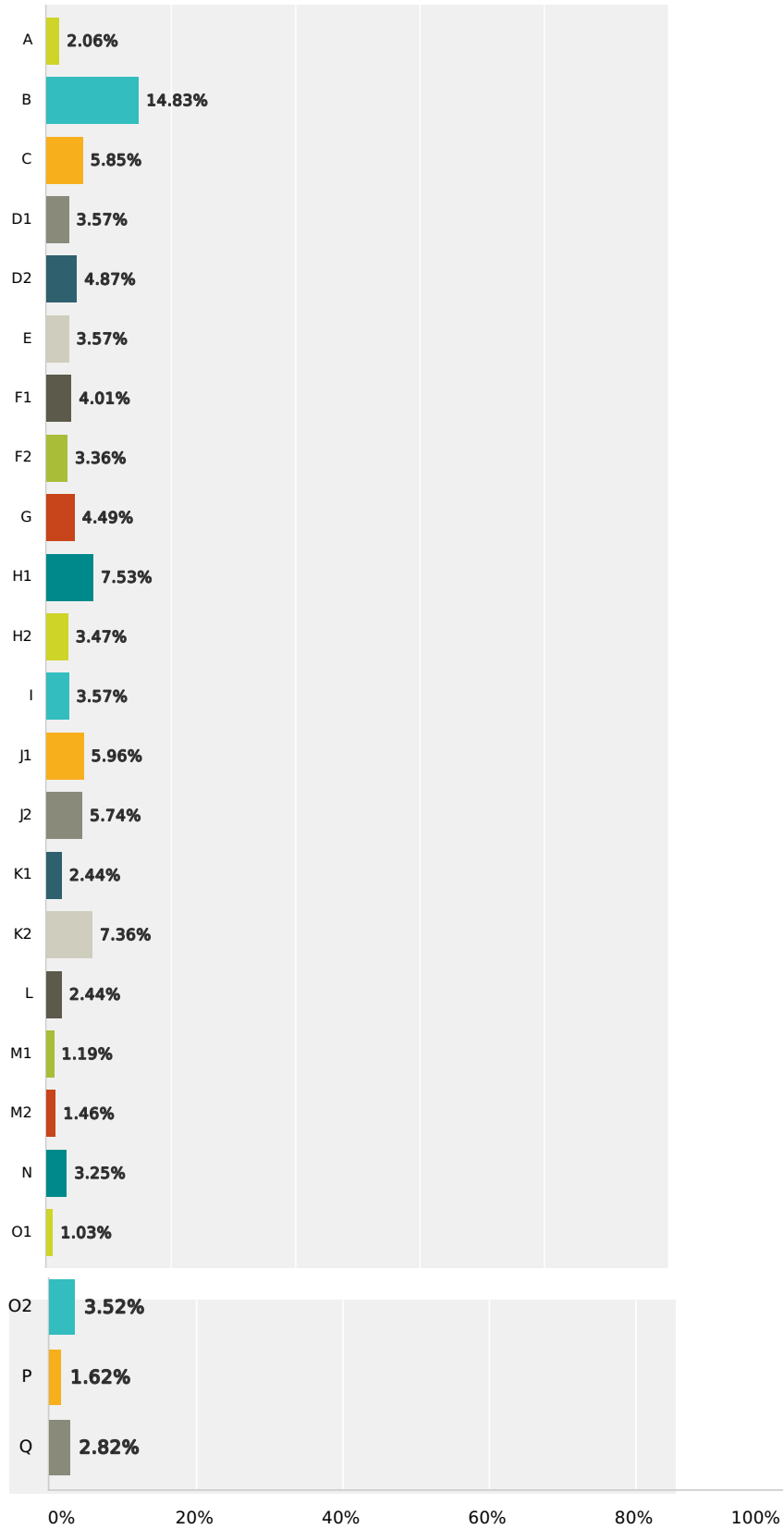
Q2 How many years have you hunted deer in Vermont?

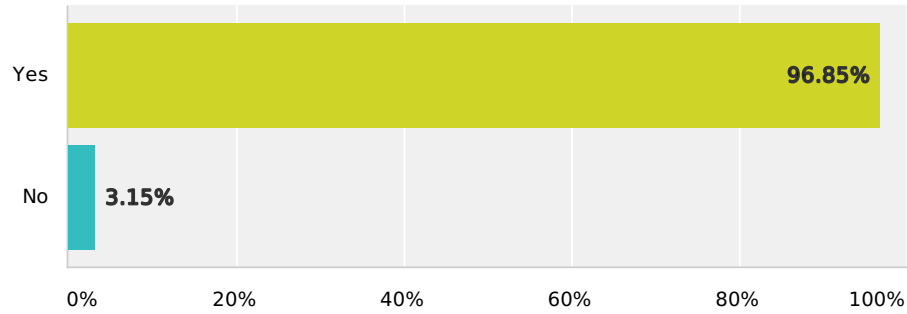
**Q3 In what Wildlife Management Unit do you spend the majority of your time hunting deer in Vermont?

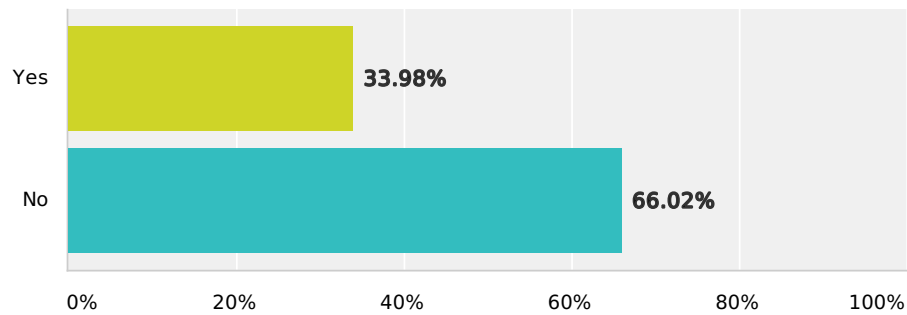

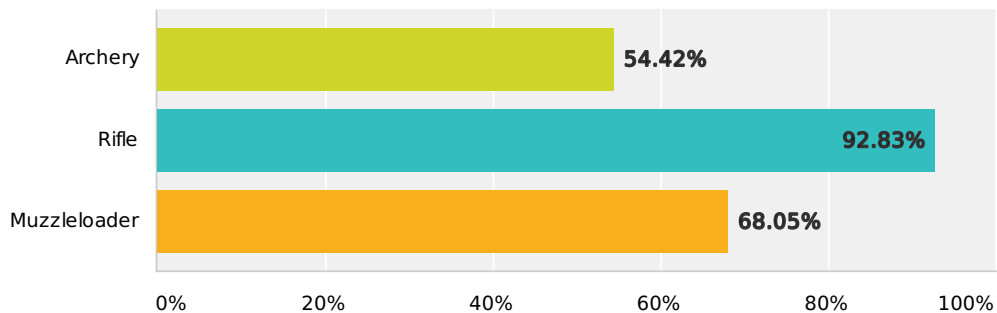

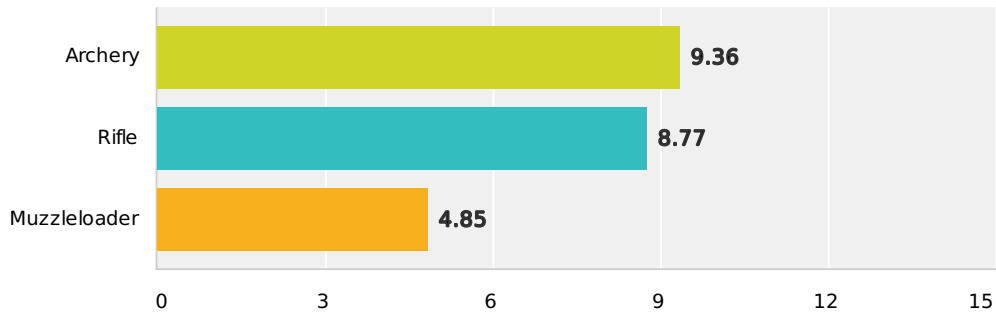

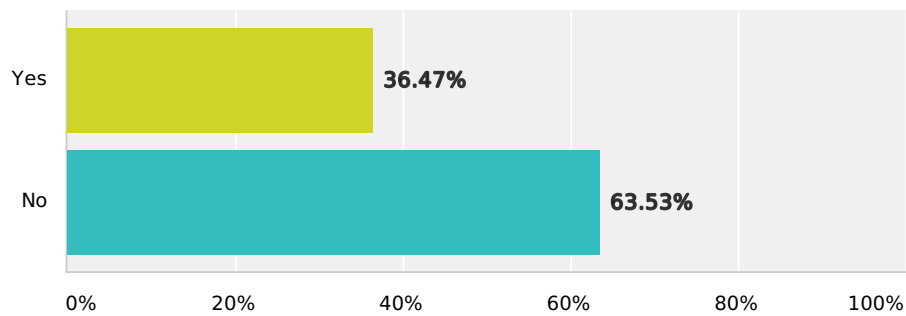
Q8 In 2012, about how many days did you hunt in Vermont during each of the following deer seasons?

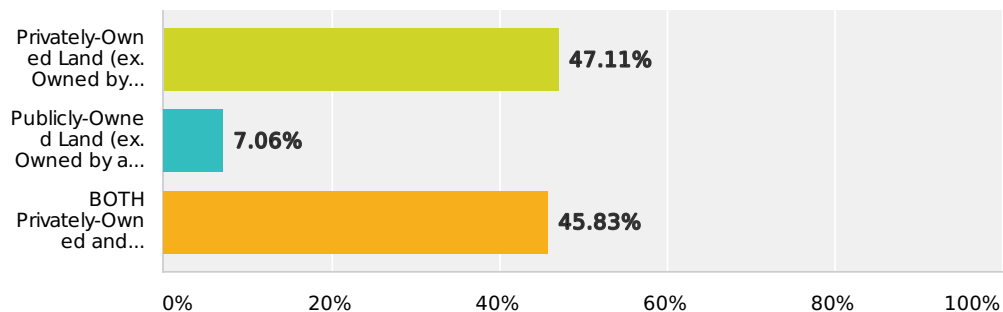

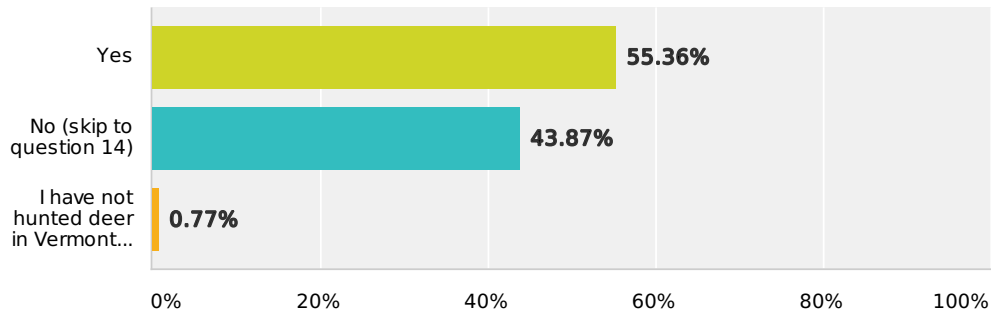

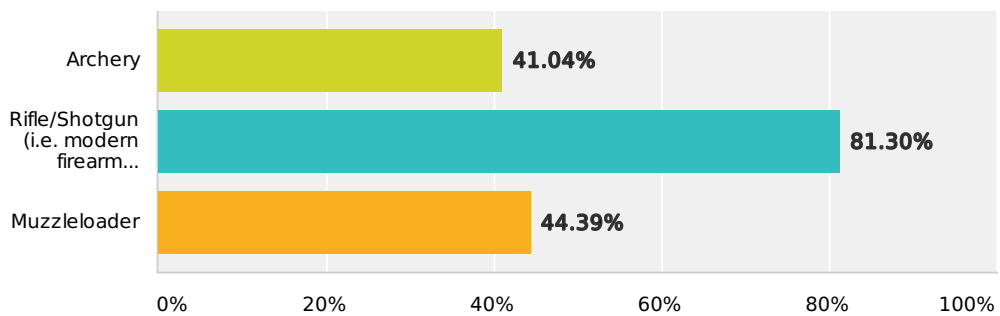

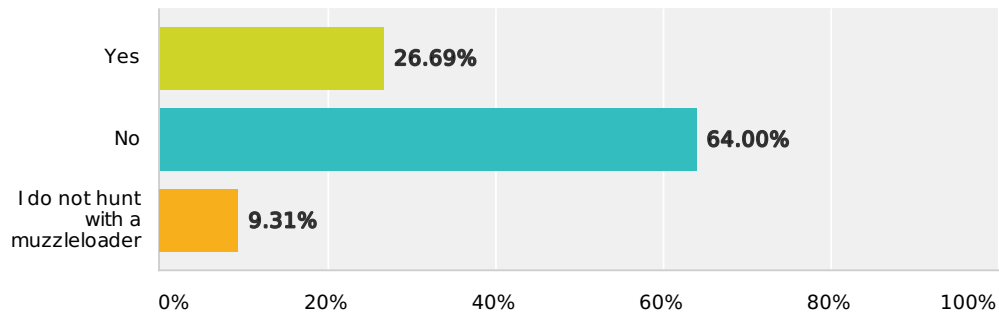

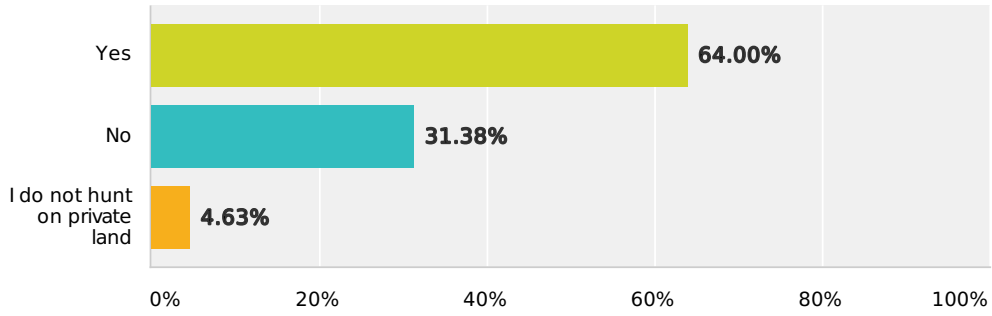
Q14 Is your participation in Vermont's muzzleloader season influenced by whether or not you possess an antlerless deer permit?

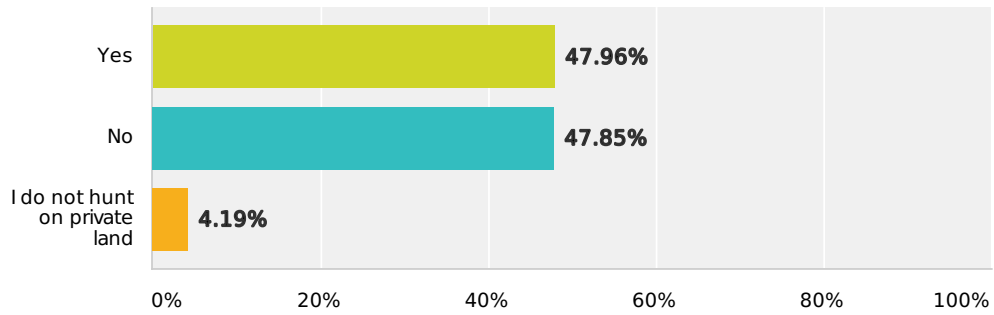

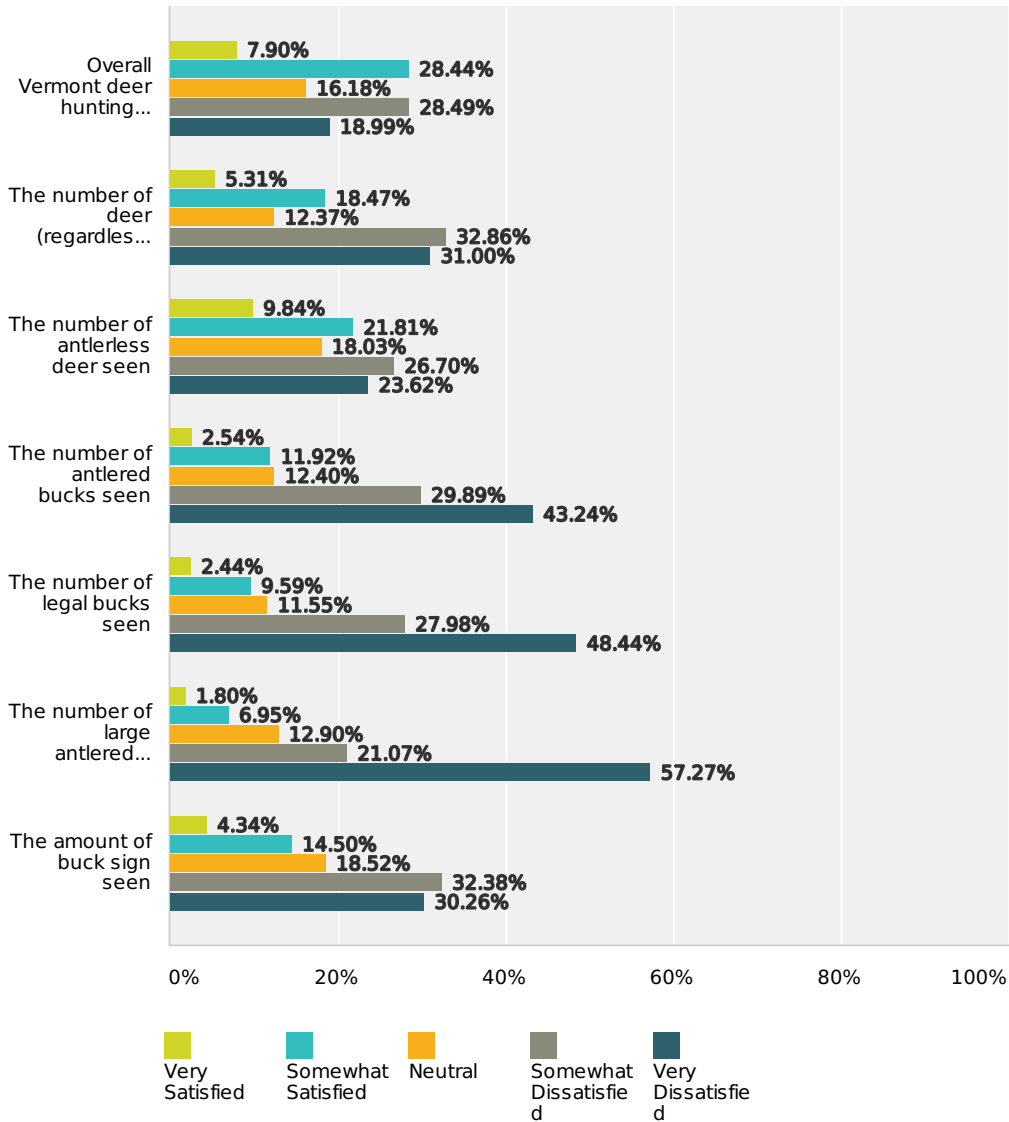

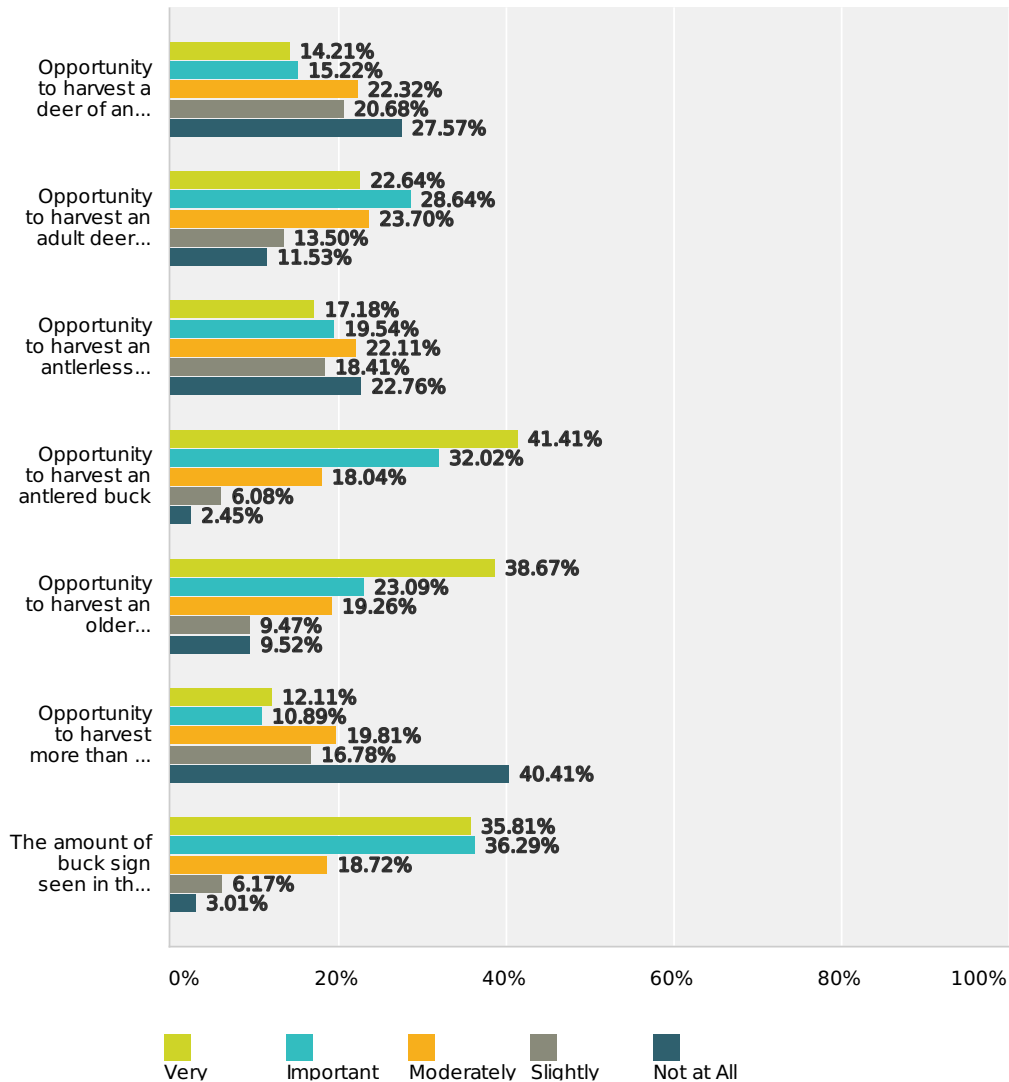
Q17 Please rate your current level of satisfaction using the following responses, in the WMU in which you spend the majority of your time hunting deer: (mark one response per row)

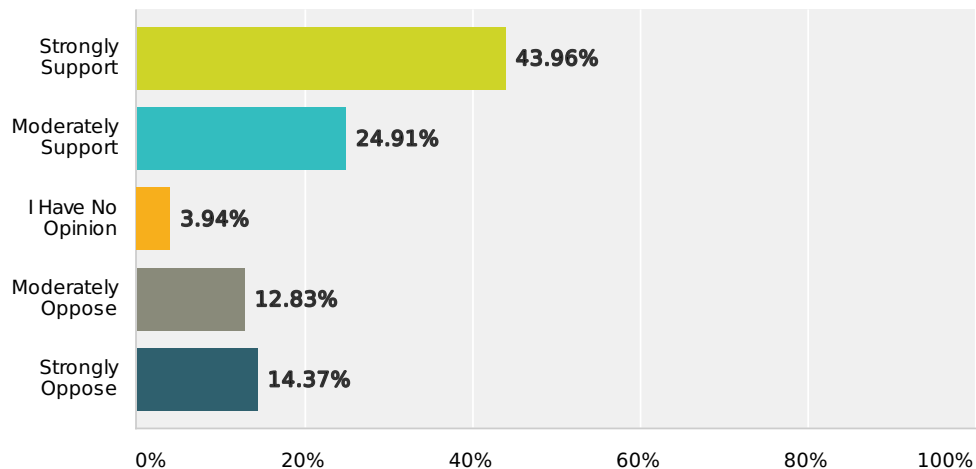
Q18 How important are the following factors to your hunting satisfaction?

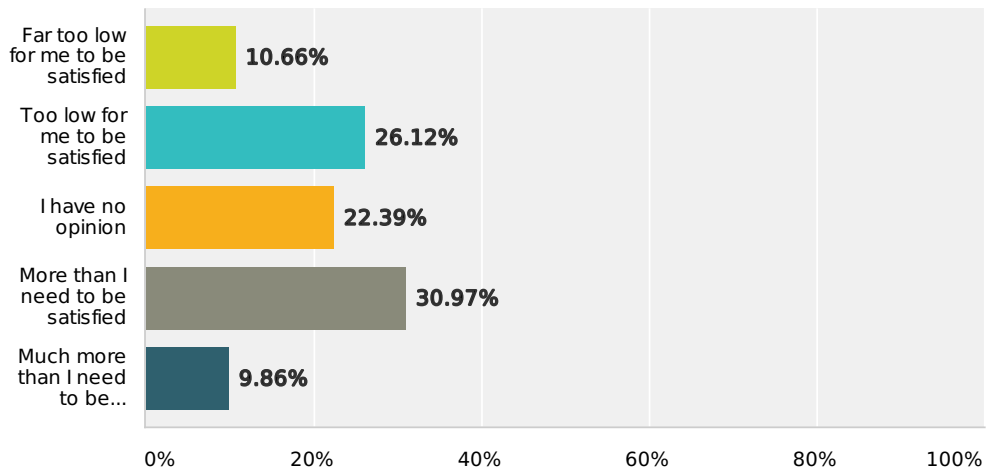

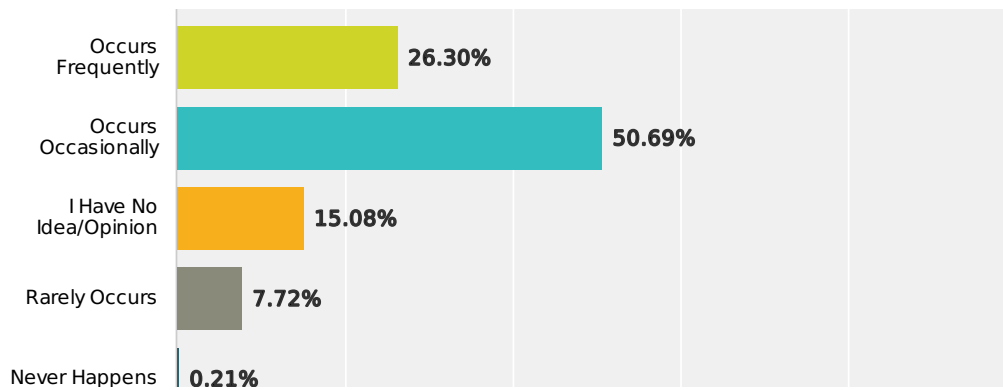

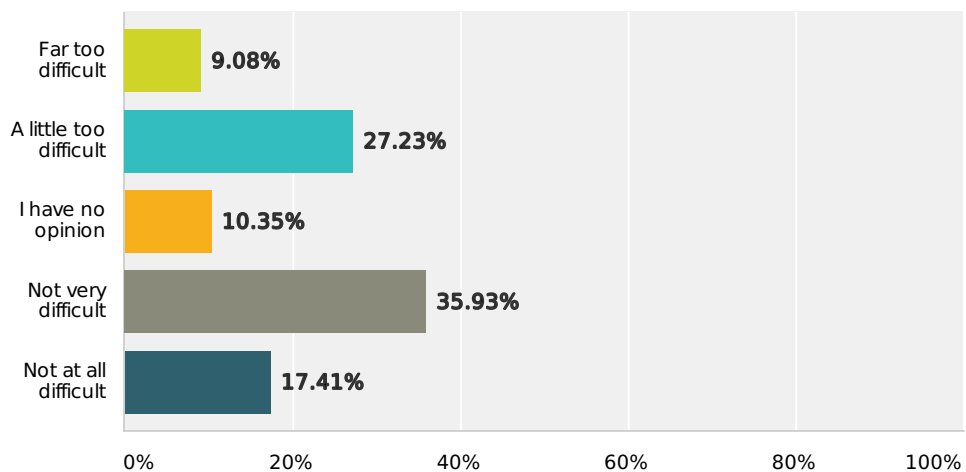

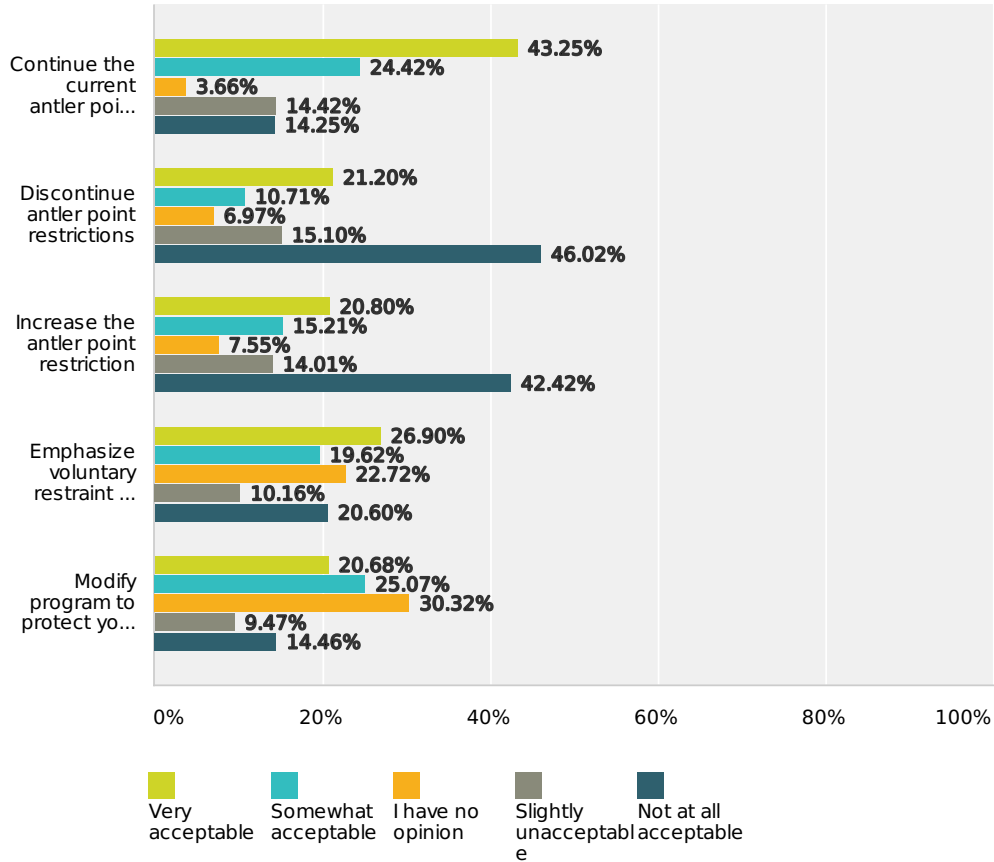

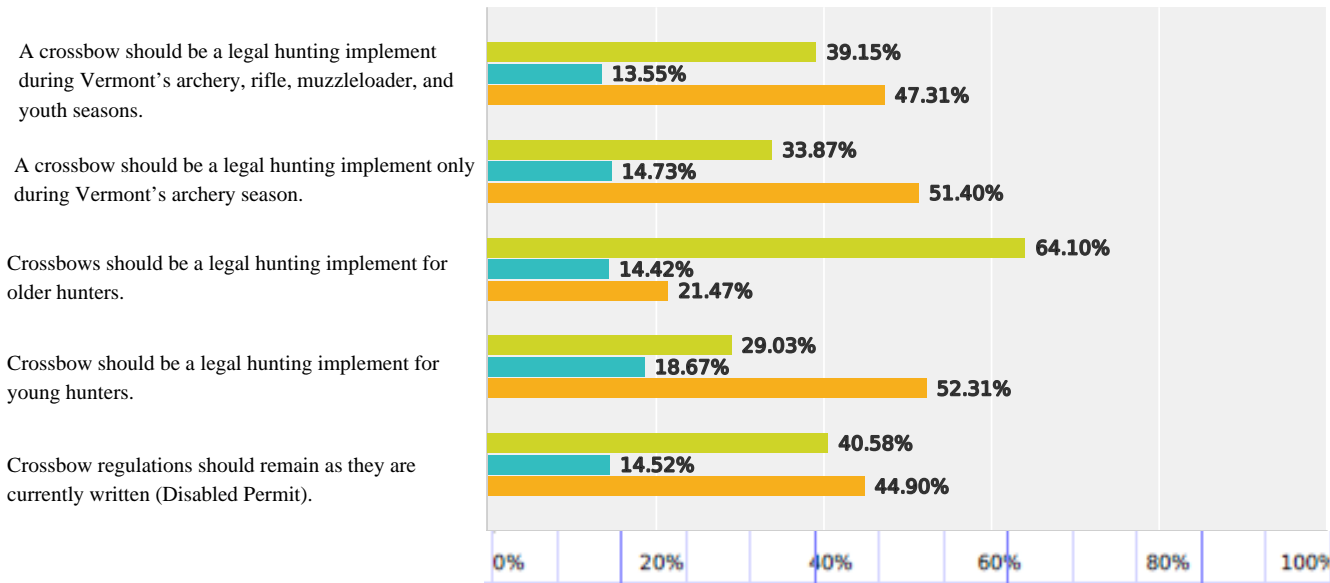

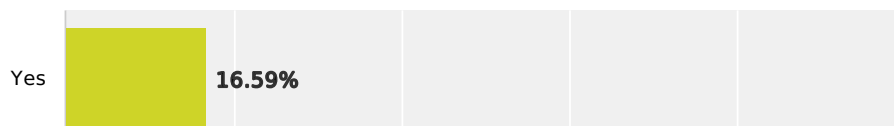
