

## Vermont Fish & Wildlife Department Lifetime License Information

- A lifetime license can only be purchased at the main office located at 1 National Life Drive-Dewey Bldg, Montpelier, VT submitted via USPS or in person.
- **A photocopy of the certified birth certificate is required.**
- Incomplete applications lacking a photocopy of the certified birth certificate, affidavit signature(s), or the appropriate fee will be returned. If rejected, the license price will be determined based on the completed application's post mark.
- A parent must attest to residency on the application by signing the affidavit(s). More than one affidavit may apply to an applicant. Please read carefully.

### A MINOR CHILD APPLICANT:

- **Minor Child under the age of 1.** The parent or legal guardian of the child **must** sign the MINOR CHILD affidavit section(s) of the application to certify Vermont residency based on the statute below. If a legal guardian certifies residency, proof of guardianship must be provided.
- **IF applicant is a VT resident, but was born out of state,** you must be able to certify and sign **both** minor child affidavits.

**“Residency signature required for Vermont applicants only: 10 V.S.A. § 4279. Lifetime licenses.....**A resident is a person who has resided in Vermont for the 12 months immediately prior to the date of application for the license and who has not during that period claimed residency in any other state or country for any purpose. A child born in this state shall be a resident if one or more of the child's parents or the child's legal guardian are domiciled in the state at the time of birth and have continued to reside in the state since the birth.”

**Lifetime License Fees:** Lifetime License fees are based on the adult license fee at time of the sale.

- Fees are determined based on date of purchase or postmark of the complete application.
- For Applicants under the age of 1, the COMPLETE application must be postmarked **PRIOR TO** the applicant's birthday. For example, if today is the child's first birthday, the costs would be found below in the column “1 – 15 years”.
