**DO NOT BRING**

- ~ Cell Phone / I-Pad / Tablet
- ~ Firearms / Ammunition
- ~ Hatchet / axes / knives
- ~ Tobacco: Smoke / Smokeless, Vaporizers
- ~ Alcohol
- ~ Illegal Drugs / Marijuana,
- ~ Electronics (ex. I-Pods, radios, hand held devices)
- ~ Hair Dryers
- ~ Candy or Food

**CAMP RULES**

1. Campers may not leave camp area except with an instructor, parent, or sponsor.
2. Swimming shall only be at scheduled times and under supervision.
3. Smoking by campers is prohibited.
4. Campers are expected to be courteous, neat, clean, and observe customary table manners.
5. Profane, obscene or abusive language is prohibited.
6. Abuse of camp property or equipment is prohibited.
7. Campers are expected to attend all scheduled activities and to abide by all other Rules of Conduct explained to them at camp.
